

Bullrush Reg'd Bulldogs - Spay/Neuter Contract

Addendum to Health Contract and Guarantee

This agreement will be signed when purchasing a puppy or older/adult dog as "pet" only. This agreement is legal and binding. If purchasing a puppy as "pet" only you will be required to have your puppy spayed/neutered before the puppy reaches nine months of age.

Spay/Neuter Agreement

The Seller, Amy Presse and the Buyer(s) **(client)**, hereby agree as follows:

In accordance with the terms of this contract: a **(color) (sex) (breed)** puppy, identified with the micro-chip # **(chip)** from the litter whelped on **(date)** out of **(sire - CKC registration#)** and **(dam - CKC registration#)**.

Permanent ownership of this dog is contingent upon your compliance with this contract. Proof of the spay/neuter must be received within fourteen (14) days after the surgery. In the event that the dog's health does not allow this agreement to be honored, the Seller (Amy Presse) must be provided with a statement from your veterinarian that this dog is not yet in physical or emotional condition for surgery. Based upon the veterinarian's evaluation of this dog, the Buyer **(client)** will contact the veterinarian and establish the earliest date that the procedure can be performed. The Buyer **(client)** will notify the Seller (Amy Presse) of this amendment in writing.

It is the responsibility of the Buyer **(client)** to ensure that the Seller (Amy Presse) has received verification that the surgery has been performed. Failure to comply with this agreement by the date below, unless otherwise agreed to in writing, will be considered a breach of the contract and the Buyer **(client)** will transport this dog back to the Seller (Amy Presse) at their expense, and will not be entitled to a refund.

****Proof of altering must come in the form of a spay/neuter certificate signed by the licensed veterinarian who performed the surgery. THE PUPPY OR DOG'S MICROCHIP NUMBER MUST BE INDICATED ON THE VETERINARIANS SPAY/NEUTER CERTIFICATE.**

CKC registration paperwork will be issued as soon as the copy of the spay/neuter certificate is received by the Seller (Amy Presse). Registration papers will be sent by certified mail. If the papers are lost, the Buyer **(client)** is responsible for obtaining new papers. We will assist by providing copies, if available.

By my signature below, I agree to have this dog spayed/neutered by no later than **(date)** and I understand that this spay/neuter agreement is an agreement that this dog will not produce a litter of puppies either as purposely bred or by accidental breeding. I also agree that should the puppy/dog not be altered that I will return the said puppy/dog back to Bullrush Reg'd Bulldogs with no refund.
